PLATINUM HEALTHCARE hereby informs all hospitals, government institutions, procurement authorities and other stakeholders involved in the procurement of C Arm, radiology and imaging equipment that all statutory and regulatory documents issued in the name of **PLATINUM HEALTHCARE** are proprietary to the Company. These include, but are not limited to:

- AERB Radiation Compliance Certificates
- Government-issued Performance Reports
- Purchase Orders and Supply Records
- Installation and User References
- Other regulatory approvals, registrations and tender compliance documents issued in the name of PLATINUM HEALTHCARE.

These documents have been issued to **PLATINUM HEALTHCARE** as a result of several years of installations, regulatory compliance and services rendered by the Company and therefore, constitute an integral part of the intellectual property, regulatory credentials, and goodwill of **PLATINUM HEALTHCARE**.

PLATINUM HEALTHCARE hereby clarifies that it has not authorised any other company, distributor, or entity to use, submit, refer to, or rely upon its certificates, performance documents, or regulatory credentials in any tender or procurement process. Such use by any third party shall be considered entirely unauthorised, misleading, fraudulent and shall not be attributable to **PLATINUM HEALTHCARE** in any manner whatsoever.

It has recently come to the notice of **PLATINUM HEALTHCARE** that certain unauthorised individuals and entities are attempting to participate in tenders by submitting or referring to proprietary documents issued in the name of **PLATINUM HEALTHCARE** without any authorisation. The Company is currently examining such instances and is in the process of initiating appropriate legal action against the persons or entities involved in such misuse.



In view of the above, Hospitals, government institutions, and procurement authorities are advised to independently verify the ownership, authenticity and source of any AERB certificates, performance reports, purchase orders, or other documents submitted in tenders that refer to **PLATINUM HEALTHCARE**. The Company hereby clarifies that it has no association whatsoever with any such unauthorised parties and shall not be responsible or liable for any consequences, liabilities, or losses arising from the use, submission, or reliance upon such unauthorised documents.

Any unauthorised reproduction, submission, representation or reliance upon documents belonging to **PLATINUM HEALTHCARE** may constitute violations of applicable laws, including but not limited to fraud, forgery, misrepresentation, unlawful use of proprietary credentials, intellectual property infringement and other violations of applicable law.

It is clarified that such misuse shall cause significant financial loss, reputational harm, and legal exposure to **PLATINUM HEALTHCARE**. Accordingly, **PLATINUM HEALTHCARE** reserves the right to initiate appropriate civil and criminal proceedings including claims for damages, compensation for reputational injury, injunctions, and all other remedies available under applicable law, against any individual or entity found using, attempting to use, or misrepresenting its documents without authorisation. Any such misuse may also attract consequences under applicable regulatory and public procurement laws before the competent authorities, for which the concerned individual or entity shall be solely responsible.

This notice is issued in the interest of transparency in government procurement and patient safety and to clearly state the disassociation of **PLATINUM HEALTHCARE** from any such unauthorised third party or individual. This notice is without prejudice to all legal rights and remedies available to **PLATINUM HEALTHCARE** under the provisions of law.
